A Bylaw to Designate the Property known - Billimun Community Centre and Historical Society-located 8 miles west of the village of Mankota, Sask. As being- Architectural, Historical or of Natural Value.

Whereas, Part 111 of the The Heritage Property Act, 1980, authorizes the Council of the Rural Municipality of Mankota No.45 to enact a Bylaw to designate, real property, including all buildings and structures thereon, to be of Architectual, Historical or Natural Value or interest:

Whereas, the Council of the Corporation of the Rural Municipality of Mankota No.45 has caused to be served on the owners of the lands and premises- known as Billimun Community Centre and Historical Society at Mankota, Sask. A Notice of Intention to be published in at least two issues of a newspaper with general circulation in the Municipality with the first publication at least twenty-one (21) days prior to the date of consideration of the bylaw and with the last publication at least seven (7) days prior to the date of that consideration:

Whereas, no Notice of Objection to the proposed designation has been served on the Clerk of the Municipality:

Whereas, the Saskatchewan Heritage Property Review Board has held a hearing to determine whether the Property in question should be designated and reported its findings of the fact and recommendations to the Council and whereas, the Council of the Corporation of the Rural Municipality of Mankota No.45 enacts as follows:

1. This is designated as being a Historical Value or Interest of Real Property known as: Billimun Community Centre and Historical Society Located: A a PtN. of SW: 7-6-9-3rd.
Commencing at a point on the Western boundaryof said quarter section Two Hundred and Twenty Five (225) feet from the South West corner thereof, thence Easterly and parallel with the Southern Boundary thereof two hundred and Ninety Five and Two Tenths (295.2) feet; thence Northerly and parallel with the said Western boundary Two Hundred and Ninety Five and Two Tenths 295.2) feet; thence Westerly and parallel with the Said SouthernBoundary thence Southerly along the aaid Western Boundary to the point of commencement.

EXCepting: Twelve Hundredths: (0.12) of an acre, more or less, shown as parcel "B", taken for Roadway, as shown on a Plan of Record in the Land Titles Office for the Swift Current Land Registration District as No. 73-SC-02781
